

2024 Animal Health Summit | Presenter Agreement

After reviewing, please sign the document and upload it with your completed Emerging Company application.

- 1. To maintain the Animal Health Summit's presentation standards, each presenting company agrees to the following:
 - Each presenting company will prepare a PowerPoint presentation for the Animal Health Summit. The presentation is limited to **10 minutes**, followed by 5 minutes of Q&A. This time limit is strictly enforced in fairness to all presenters.
 - Teaser videos will be recorded via Zoom July 31 August 2.
 - The Corridor staff will assign each selected company an individual coach who will help them prepare their presentation.
 - In addition to working with individual coaches, selected companies will be required to participate
 in two scheduled practice sessions before their final presentation during the 2024 Animal Health
 Summit. The first session will be July 11, and the second session will be July 25. These
 sessions are mandatory and are extremely important, so please mark your calendars now.
 - Presenting companies will complete a company summary template, provided by the Corridor staff, by July 19, 2024.
- 2. To evaluate and track the Animal Health Summit's impact, each presenting company agrees to inform the Corridor staff regarding all future funding.
- 3. As a selected presenting company, your **registration fee** will be **\$700 USD**. In addition to your presentation and company profile, this registration includes one (1) all-access pass to the Animal Health Summit. Additional registrations can be purchased via the Animal Health Corridor website.

Please note: Final payment is due by Friday, July 19, 2024.

- 4. The selected presenting company agrees that KCADC may use the company's name, photos of the company from the event and other non-confidential facts concerning the company in marketing and other materials, including without limitation on its website, for the promotion of the Animal Health Summit, provided that KCADC shall not disclose or otherwise use Proprietary Information in any such materials. KCADC will record a teaser video via zoom and LIVE company presentations during the event on August 26-27. KCADC may use portions of this video for promotion of the event, including without limitation on the digital event platform and social media.
- 5. Please be aware that a presentation at the Animal Health Summit may be considered a form of "general solicitation" or "general advertising" for purposes of SEC Regulation D. KCADC has not and will not undertake any actions to verify the status of any person attending the Animal Health Summit as an accredited investor under SEC Rule 506(c)(2)(ii). Each participating company should consult with its own legal counsel for direction in complying with the federal and state securities laws in connection with its presentation at the Animal Health Summit.
